REGISTRATION

Requests to join a particular tour must include all the information listed above and must be received sufficiently in advance of the activity date requested.

RATES

The rates listed in the program are per person and cover the specified activity for the duration of the excursion.

All prices are inclusive of VAT .

In the case of multi-day treks , you will be required to send a deposit on making the booking which will be used secure the booking of tickets and/or accomodation.

PAYMENT

Payment for day trips is made on the day, (before the trek begins) in cash.

The balance must be paid in full no later than the first day of the trek, in cash.

CANCELLATION OF RESERVATIONS

If the Guide cancels : 100 % of the deposit already paid will be refunded.

If you cancel :

* More than 7 days before the trek : 100% of the deposit already paid will be refunded

* 7 days or less before the trek : 50% of the deposit already paid will be refunded.

If for any reason the excursion should be shorter (in time) than advertised, no refund will be made.
